# Side event on Property Rights, Housing, and Early Recovery on Sidelines of the Seventh Brussels Conference

Session Date: June 13, 2023

The Syrian conflict, which began in 2011, has witnessed numerous violations of land, housing, and property rights by various controlling forces. Of particular concern is the Syrian regime's efforts to legitimize these violations through a series of real estate legislation.

These violations have had a direct impact on the return of Syrian refugees to their home country, as Security Council Resolution 2254 emphasizes the return of displaced individuals and refugees to their "areas of origin." However, the imposition of security approvals on real estate transactions and restrictions on property disposal have hindered this process.

What is alarming is the recent agreement by the Security Council to renew cross-border aid entry to areas outside the regime's control, under the condition of using the term "early recovery." This term aligns with the regime's interpretation of the "reconstruction" process. The inclusion of this term may provide the regime with the means to expedite reconstruction within a legal framework that discriminates against refugees and dissenters.

It is important to note that UN Resolution 2254 of 2015, as well as the European Union and the United States, emphasize that the reconstruction process in Syria should not begin until the conflict is resolved through a political solution. With the absence of progress in this political solution, the rush towards early recovery activities poses an imminent threat to land, housing, and property rights in Syria. This situation coincides with the current stage of Arab countries' engagement with Damascus, which has exploited the catastrophic aftermath of the February 2023 earthquake. All these factors contribute to the financing of early recovery activities, blurring the line between them and reconstruction, and supporting economic stability in Syria under the Syrian regime's influence.

Considering these concerns, The Day After and Syria Report will host a session on the sidelines of the Brussels conference, focusing on housing and property rights, and the potential impact of early recovery activities.
