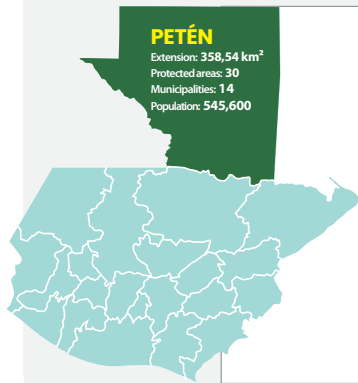
Link the socioeconomic development of the region with the protection and sustainable use of natural resources.
