2. Bosnia and Herzegovina

In 2018, Bosnia and Herzegovina (BiH) hosted a two-day National Stakeholder Dialogue with participation of over 50 persons including representatives of the Bosnia and Herzegovina Mine Action Centre (BHMAC) from various provinces, various national departments, donor/partner states and organisations -- including non-commercial operators, representatives from mine-affected communities including local authorities and mine survivor organisations. Acting on recommendation stemming from the 2018 Dialogue, in which participants invited BiH to have a more "transparent"



extension request process than in the past, BiH held a national technical meeting in March 2020 with some of these partners. About 30 persons attended the meeting which

was welcomed by participants. BiH is also working closely with the EU Delegation in country and other States to make progress in its mine clearance goal. 3. South Sudan



The <u>National Mine Action Authority (NMAA)</u>, is responsible for victim assistance coordination. The NMAA has been instrumental in promoting conversations on disability rights and victim assistance in partnership with the Ministry of Gender, Child and Social Welfare of South Sudan. The Ministry together with the NMAA hosted a three-day Dialogue in Juba with more than 60 participants in 2019. Through follow up support, in August 2020 South Sudan hosted consultations on its draft national plan with participation of its partners.

Civil society partners included the <u>ICRC</u> which participated in the 2019 and 2020 meetings. The Director of Rehabilitation for ICRC in South Sudan provided feedback on this process and on the important inclusion of civil society in these consultations. ICRC is one of a handful of organisations that have the technical know-how when it comes to rehabilitation and health care as it relates to mine victims and other persons with disabilities in South Sudan. *See the video recap of the workshop:*

4. Uganda

A key aspect of the Decision has been to support implementation of victim assistance in States Parties that have fulfilled their Article 5 obligation. However, maintaining victim assistance and disability

rights in the national consciousness requires effort. Through the project, Uganda held a national stakeholder dialogue with over 50 participants to start the development of a national action plan on disability. Through follow up support, Uganda launched the recently adopted plan in August 2020. The VA focal point explained the process under the project and challenges that remain. Restrictions due to Covid-19 have put the plans on hold but new alternative plans are being developed to ensure that the Dialogue can still be held before the project ends in February 2021.

6. Organisation of American States (OAS)

In view of Chile's completion, only four States with Article 5 obligation remain in South America: Argentina, Colombia, Ecuador and Peru. Together with the Implementation Support Unit, the Organization of American States (OAS), which first implemented a mine clearance programme in 1991, will host a regional stakeholder dialogue with support of the EU, to raise awareness of the newly adopted Oslo Action Plan and better assist in efforts to bring the Americas to completion.
